In addition to Medicare payment systems, Web.Strat provides support for more than 30 state- or payer-specific payment systems. And, because Web.Strat is browser-based, it can be easily deployed to multiple users throughout the enterprise. In addition, an OptumInsight-hosted (ASP) version of Web.Strat is available that requires no user software other than a Web browser with Internet access.OptumInsight manages all the software updates as they are released to the customer base.
